## Privacy Policy for web users who fill out the form "Contacts" and access on-line catalogue ("Informative")

2.	Data controller	O.M.P. Officine Mazzocco Pagnoni S.r.l. (the "Company"), whose contact details can be found on the contact page, undertakes to protect personal data in accordance with (i) Regulation (EU) 2016/679 on the protection of physical persons with regard to the processing of personal data and on the free movement of such data and that abrogates the Directive 95/46/EC ("GDPR") as well as (ii) the Italian national legislation on the protection of personal data ("National Data Protection Laws").
	processing authorization	specific contractual title) with special reference to those working in the areas involved in order to acknowledge the request (e.g., sales, production, administration, etc.) may process the data as they are authorized to process, in accordance with the provisions of the National Data Protection Laws and of the Article 29 of the GDPR.
3.	Recipients of processing	The data may be processed by external parties who, depending on the cases and in relation to the agreements with the Company, may act as autonomous self-employed holders, co-holders or external data processors, who belong to the following categories:  (i) companies belonging to the same corporate group;  (ii) providers of IT infrastructure development, management, support and maintenance;  (iii) providers of management software, applications, hardware and relative support/maintenance;  (iv) connectivity and e-mail service providers and related support/maintenance;  (v) legal, accounting and auditing, environmental, workplace safety, tax and quality consultants.  The Company provides specific information regarding managers and recipients upon request of the interested party.
4.	Concerned with the processing	The interested parties ("Interested") are the web users that, through omppump.com site or other company sites, make the contact request by filling out the form available in the "contact" section on the site <i>omppumps.com</i> or user that are allowed to access the company on-line catalogue.
5.	Personal data processed	The personal data that are processed by the Company, by automated and non-automated means, are: - first and last name; - e-mail address; - telephone number; - any other personal data that may be entered by the web user in the text of the message (with the understanding that such inclusion is not recommended); - username to access the company on-line catalogue. The data are associated with the entered message.
6.	Purpose of processing	The processing of the Interested party's personal data has the aim to allow the Company to receive messages/requests, to respond to the queries and to evade the requests by addressing them to the relevant offices/areas.

7.	Legal basis of processing	The processing of the Interested party's personal data is necessary for the satisfaction of the related requests.
8.	Data storage time	The data of the Interested parties are stored for as short a time as necessary to the simple fulfillment of the contact request and in any case for no longer than six months, unless a new legal basis intervenes for the processing (for example, execution of contractual obligations).  Credentials used to access on-line catalogue are deleted whenever requested by the user or if the user is no more interested in it.  Credentials are deleted even when the company decides, at its own discretion, to cease the on-line catalogue function.
9.	Nature of conferment	The conferment of personal data is entirely free and not mandatory. In the absence of the conferment, it is not possible to fulfill the requests.
10.	Mode of processing	The personal data are processed with means of suitable measures for the safety and the confidentiality of the same data.
11.	Rights	Each Interested party can practice, by sending an e-mail to the address <code>privacy@omppumps.com</code> , the rights expected by the GDPR (articles 15 e ss.), and, in particular, access to their proper personal data, requesting the rectification and updating or the cancelling, limitations, as well as requesting the portability.
12.	Complaint	The Interested party also has the right to propose a complaint with the relative Supervisory Authority.
13.	Updates and revisions	The Company reserves the right to modify and/or update the Information Notice, also taking into account any and subsequent additions and/or modifications of the National and/or European Union data protection regulations or as a result of any additional purposes of data processing. The new versions of the Policy will replace the previous ones and will be valid, effective and applied from the date of publication on the Company's website.
